Individual **in-text citations** use the ASABE style which differs slightly from the APA 6th.

2. Article Processing Charge (APC or page charge)

For a fee of \$1500, in addition to the APC, your article will be freely available in our online Technical Library, allowing anyone to view the full article under the Creative Commons CC BY-NC-ND 4.0 license. This fee also allows authors to immediately share the published version, including posting to article-sharing sites. Commercial copying or redistribution is prohibited. Pay the open access fee when you send the payment form that comes with your layout proof.
